Our agency worked with **57 parishes and 28 Catholic schools**. We provided support through volunteers, food drives, holiday gifts, donations, and more.

### Lake City Seniors Get Help and Pay It Forward

The Lake City Commodity Supplemental Food Program (CSFP) was designed to provide low-income seniors with monthly food boxes and meaningful connections, yet it also inspired the recipients to give back themselves. The program's staff and volunteers deliver 35,000 pounds of nutritious food to 993 seniors across three counties each month. As they've hosted community distributions and made deliveries to homebound seniors, they've also nourished relationships. In doing so, they learned that Ms. B, a 79-year-old woman whose house was destroyed by Hurricanes Debbie and Helene pays forward the help she receives by personally delivering food to five other families. "Everything we give her, she wants to share," said Shannon Moser, Regional Director of Catholic Charities Lake City. "She finds seniors in need and spreads the word that we're here to help, even when she needs the resources herself." Several other octogenarian CSFP recipients also regularly volunteer, showing how one good deed leads to far more.

Our Homelessness Prevention Program provided case management and temporary financial assistance for those in our community facing financial difficulties, such as loss of income or unexpected medical expenses.

#### Assisted 1,145 Refugees

Refugee programs assisted individuals with their quest to establish peaceful and safe new lives in the United States.

#### **Supported 521 Families**

Pro-Life Programs facilitated the adoption of 14 babies through pregnancy counseling, home studies, and pre- and post-adoption support in all 17 Diocesan counties, as well as in Lake, Marion, Sumter, and Volusia counties.

#### **Empowered 187 People**

Self-sufficiency programs provided services and education that help individuals become more financially self-reliant.

#### **Engaged 172 Campers**

Camp I Am Special provided camp experiences to children, teenagers, and young adults with intellectual and developmental differences.

#### Taught English to 2,793 Students

Non-native speakers improved their English skills through our ESOL programs.

#### Spread Joy to 6,382 Kids and Families

Holiday Assistance helped families and children enjoy the holidays with food and gifts.

#### Fostered Wellness for 1,869 Individuals

The Ryan White Program assisted low-income persons living with HIV/ AIDS with intake, referrals, and case management services.

#### Nourished 3,971 Students

The Weekend Hunger Backpack Program assisted low income, food insecure children by giving them backpacks filled with nutritious food for weekends and holidays.

#### Fed 95,977 People

Our food pantries, outreach programs, and the weekend hunger backpack program helped people feed their families with 1,910,164 pounds of food.


## Distributed 1,825,796 Pounds of Food


